a. Information Provided by You

- Name and email address

- Visa application details and supporting documentation
- Housing and insurance requirements

b. Information Collected Automatically

- IP address and browser type
- Device and operating system details
- Pages visited and time spent on the Site
- Cookies and tracking data

3. Purpose of Processing

Data is used for:

- Arranging housing and insurance solutions
- Improving the Site and user experience
- Fulfilling legal obligations

4. Legal Basis

Processing is based on:
